RE: Economic measures during COVID-19

Dear Prime Minister,

On behalf of the Canadian Association of Optometrists (CAO), the national voice of optometrists in Canada, I'd like to commend the Government of Canada for its quick action to help Canadians facing hardship as a result of the COVID-19 outbreak. However, based on analysis we received from an accounting firm, we have identified perceived gaps in the economic response plan that have a negative impact on optometrists. We are asking the government to consider amendments to the legislation to make the current benefits more accessible to optometrists.

In the first instance, the Canadian Emergency Response Benefit (CERB) does not apply to the majority of self-employed optometrists who lose income when they stay open to respond to emergencies, which while alleviating pressure on hospital emergency rooms, are not numerous in nature. Doing so in the absence of financial support is not economically feasible.

Secondly, the CERB doesn't apply to optometrists who are incorporated and receive their income exclusively through dividends.

There is an opportunity to strengthen the economic response package to include optometrists who wish to provide emergency patient care during the COVID-19 outbreak, without suffering undue economic hardship. We encourage the Federal Government to re-examine the Canadian Emergency Response Benefit and look for a solution that supports ongoing contribution of care delivery by optometrists and other regulated health care professionals practicing primarily in the private sector during these exceptional circumstances.

CAO welcomes the opportunity to discuss this issue with your staff in greater detail. A member of my staff will contact your office to arrange appropriate follow up.

Again, thank you and your government for your efforts to date.
